## CATHOLIC ORDER OF FORESTERS

### MINNESOTA COF 2012 SCHOLARSHIP PROGRAM

**GOAL:** To assist COF members in their post-secondary education programs.

1. Applicants **must be no more than Twenty-one (21) years of Age by December 31, 2011.**
2. Applicants must have graduated High School by August 1, 2012.
3. To qualify, each applicant must be a member of a Minnesota COF Court by January 31, 2010.
4. Applications must be made to the Minnesota State Court Scholarship Fund by January 31, 2012.
5. Selections will be made by a random drawing from all applications received. Drawing will take place at the 2012 State Convention and under the supervision of all State Court members present.
6. Each recipient will receive a \$500.00 award. Fifteen (15) scholarships will be awarded.
7. The first 15 names drawn are the winners; the next ten names drawn will be the alternates.
8. All winners will be notified by May 15, 2012.
9. Local Courts will be notified so as to obtain publicity of the award, and the local high schools will also be notified if the winner is still in high school.
10. **The check will be mailed to the Student payable to the Student Only in December 2012. Since the checks are no longer going to the school, students will need to provide proof of attendance from the 1<sup>st</sup> semester 2012 (a transcript is acceptable).** Funds will be given to the student even if they quit during the semester, because they still have incurred expenses.
11. If the student does not attend a post-secondary institution, no award will be given and an alternate candidate will receive the scholarship.
12. Only one COF scholarship for post-secondary education per student. If a National and a State scholarship are received the National award will be considered the prime award and the Minnesota scholarship will be passed on to an alternate candidate in order of names drawn.
